3. The payment of Grants-in-aid is in accordance with procedure as laid down in the Ministry of Finance, Department of Economic Affairs, O.M.No.8/4/E.II (A),/05 dated the 29<sup>th</sup> March 2006 and as per provisions contained under Rule 230 (1) to 230 (16) of the General Financial Rules, 2017.

4. The amount will be drawn and paid to Odisha State Agricultural Marketing Board (OSAMB), Bhubaneswar through Real Time Gross Settlement (RTGS), payable at State Bank of India, Account No. 31183693222, Priyadarshini Mkt., Bhubaneswar-751012. The details in the prescribed proforma are enclosed.

5. In so far as Odisha State Agricultural Marketing Board (OSAMB), Bhubaneswar is concerned hence no utilisation certificate is pending for NAM scheme.

6. OSAMB, Bhubaneswar shall provide monthly achievement-cum-performance progress reports and disclose whether the specified, quantified and qualitative targets that should have been reached against the amount utilised, were in fact reached, and if not, the reason therefor under the scheme to this Ministry and in the end of Financial Year shall submit a Utilization Certificate in the prescribed format (Form 12-A as indicated in Rule 238 (A) of GFR 2017) and an audited statement of account on the basis of actual utilization of Grants-in-aid as laid down under Rule 235 of GFR, 2017.

7. OSAMB, Bhubaneswar shall utilize the grant-in-aid in the public interest and strictly for the approved components of the scheme within the terms and conditions laid down by the EFC and CCEA. In case of any violation or deviation or diversion of funds, it will be binding on the implementing agency to refund the fund with interest. OSAMB, Bhubaneswar shall strictly follow the procedure relating to Audit of Accounts of Grants-in-aid as laid down under Rule 236(1) to 236(4) of General Financial Rules, 2017.

8. The accounts of OSAMB, Bhubaneswar shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor-General of India under the provision of CAG (DPC) Act, 1971 and Internal Audit by the Principal Accounts Officer, Ministry of Agriculture & Farmers Welfare, Department of Agriculture & Farmers Welfare, whenever called upon do so.

9. This is a Non-Recurring grant. Odisha State Agricultural Marketing Board (OSAMB), Bhubaneswar shall strictly follow the guidelines/orders relating to pattern of assistance issued by M/o Finance, Department of Expenditure, Government of India from time to time. Odisha State Agricultural Marketing Board (OSAMB), Bhubaneswar shall maintain subsidiary accounts of grants-in-aid as required under Rule 235 of the GFR 2017.

10. Noted at Serial No. 60 in the register of Grants.

11. Utilisation Certificate in the Form 12-A of GFR 2017 should be submitted within 12 months from closure of the financial year. The grantee institution shall submit the Utilisation Certificate on PFMS as per Rule 86 (6) of GFR 2017.

12. The further use of Grants in aid being released by this Sanction order, is to be done through EAT module of PFMS. The Utilisation Certificate not supported by the EAT module data is likely to be rejected and expenditure is not to be treated as regular. The agency would be forced to refund the amount received as the expenditure not appearing in EAT module data is not to be taken as expenditure incurred in accordance with the terms and conditions of this Sanction Order.

13. This is further certified that Integrated Scheme on Agriculture Marketing (ISAM) (9006) is purely a Central Sector Scheme hence no State share is involved under it. SNA waiver for the scheme has already been obtained from competent authority.

14. This sanction is issued in the exercise of delegated powers in consultation with Integrated Finance Division, Department of Agriculture vide their **Dy.No -113312/AS&FA/ dated 9<sup>th</sup> March 2023**
